Executive Summary

The Association for Criminal Justice Research and Development (ACJRD) has hosted a wide array of events and seminars during 2019. These included our 22nd Annual Conference entitled "Behind Closed Doors: Crimes of Violence, Coercive Control and Abuse in Family and Intimate Relationships", and the 6th Annual Irish Criminal Justice Agencies Conference entitled "Sexual Offences: The Challenge of Balancing Rights in the Criminal Justice System" which was a collaboration of the ACJRD, the Office of Director of Public Prosecutions, the Irish Youth Justice Service, The Probation Service, The Department of Justice and Equality, the Irish Prison Service, and An Garda Síochána. The ACJRD also held Working Groups seminars and events at which attendees had the opportunity to contribute their opinions and share perspectives.

The Association also continues to further current and future Research opportunities, maintains a membership base and a number of Working Groups and also contributes to the criminal justice community in Ireland via quarterly newsletters and continued memberships and relationships with other not-for-profit organisations who share common ground with the objectives of the ACJRD. The collaboration with Northumbria University and Queen's University Belfast on a UK-Irish Criminal Justice Cooperation Network, which began in 2018, continued throughout 2019.


2. Membership

Suggestions from this initial meeting were presented to the full Council furthering ongoing discussion.

Roundtable: Draft Oberstown Children Detention Campus Rules and Support Policies - 9th May 2019

The Chair of Oberstown Campus Detention Centre (OCDC), contacted ACJRD as a stakeholder in the field asking for input into their Draft Oberstown Children Detention Campus Rules and Support Policies document.

ACJRD invited members of its Juvenile Justice Working Group to a Roundtable to give feedback on the Draft document that had been shared with them, on a confidential basis with Oberstown's consent. The outcomes of the Roundtable were submitted to the Chair of Oberstown Campus Detention Centre for consideration.

Seminar on the Bail Supervision Scheme - 10th September, 2019

In circumstances where there were reservations during court proceedings to grant bail to a young person accused of wrongdoing, The Bail Supervision Scheme (BSS) offers those courts an alternative option to detention by offering them the possibility of granting bail with intensive supervision.

By reducing the need for remand places, this also provides an opportunity to focus on developing successful community resources designed to prevent young people being detained in a youth justice facility and preventing them from entering further down the path of criminality. Further

4. Research Collaborations

A Changing Landscape

In its formative days the ACJRD (then IASD) would commission research and or engage the services of researchers when the Association won a research tender. Nowadays ACJRD is often approached by third parties who require a civil society partner to engage in and or facilitate research that has been successfully tendered for.

Council Members engaged in discussions on the implementation of a Strategic Review that included a recalibration of how ACJRD could facilitate the criminal justice research community. It was agreed that our members would be best served by the Association facilitating both commissioners of research and individual researchers. These ideas were discussed intermittently during 2019, with an aim to implement the conclusions of deliberations of new structures during 2020.

5. Student Engagement

ACJRD Academic Sponsorship in Maynooth University

ACJRD continues its academic sponsorship with Maynooth University. Jana Khalil won the Maynooth University | ACJRD Best Criminal Law Essay (2019). The 2019 essay theme was "Discuss critically (with reference to relevant case-law and academic commentary) whether the legal principles relating to a break in the chain of causation are satisfactory".

9. AGM 2019

The ACJRD Annual General Meeting was held at the Richmond Education and Event Centre on Friday, 11th October, 2019, following the close of our annual conference. At this meeting of ACJRD members the association's Auditors, Browne Murphy and Hughes, presented the ACJRD audited accounts 2018 for adoption by members.

10. International Collaboration

The UK-Irish Criminal Justice Cooperation Network

In 2018 the ACJRD began a collaboration with Northumbria University and Queen's University Belfast on a UK-Irish Criminal Justice Cooperation Network.

The UK-Irish Criminal Justice Cooperation Network is an initiative which is funded by the Arts and Humanities Research Council and led by Northumbria University in partnership with Queen's University Belfast and the Association for Criminal Justice Research and Development in Ireland. The funding commenced on 1st October, 2018, and the project was initially intended to run for 18 months. The Network aims to bring together policymakers, practitioners and academics to consider the implications of Brexit for criminal justice cooperation between Ireland and the UK. A range of expertise to include academic, policy and practitioner perspectives have been considered, to ensure that the Network constructs maximum sharing of expertise for the benefit of all participants and their stakeholders.

The Network comprises a core group of approximately forty participants and aims to deliver three workshops where the Chatham House Rule¹ applied and a final conference with public access (in Northumbria University). Ireland's Network members were nominated by the ACJRD, many of them from amongst our membership.

Three workshops were held in 2019. The first workshop, "Overview of Article 50 Negotiations Process and Principles and Policing Perspectives", was held on 11th January, 2019, in the Law Society of Ireland, and was facilitated by ACJRD. The second workshop, "The Changing Landscape in Criminal Justice: How to Keep the Lights On" was held on 10th April, 2019, in Queen's University Belfast and facilitated by that university. The third workshop, "UK-Irish Policing cooperation after Brexit: exploring European perspectives" was held on 29th November, 2019, at the Law Society of Ireland, and was facilitated again by ACJRD. A Conference is scheduled to be held in Northumbria University in 2020.

The unknown nature of Brexit and the constant postponement of milestone dates have inevitably impacted the Network discussions. There are plans to publish the outcomes of these workshops and conference in due course.
