The ACJRD working groups are the vehicle through which ACJRD members can input into the activities of the association.

The groups utilize members knowledge and expertise in respect of each topic and promote discussion and debate within each working group and the interesting seminars / lectures and workshops they organise. The ACJRD working groups currently established include: Education, Mental Health, White Collar Crime. Reintegration. Restorative Justice and Addiction.

Each of the groups was active during 2010 and seminars were held on each theme with a good attendance and interesting discussion at each event.

In November the focus was on the Issues of Mental Health in the Irish Criminal Justice System. Siobhan Young, Head of Mental Health, Irish Youth Justice Service, Fergal Black, Director Healthcare, Irish Prison Service. Michael Brennan, Researcher, Trinity College Dublin & Dr. Damien Brennan, Sociology Dept. Trinity

College Dublin all shared their expertise.

Education on the inside - a view of the educational process in Irish Detention Schools and Prisons was the theme during October. Anne Marie Byrne, and Jane Carrigan Ph.D candidates at St Patrick's College, Drumcondra made presentations on Education for young offenders in detention schools and education for adult prisoners, from a life-history point of view respectively.

### **Report on Working Group Activities continued**

In September, Fiona Ryan of Alcohol Action presented a seminar on Addiction.

In August, representatives from the ACJRD and the Mental Health working group met with Minister Moloney, Department of Health and Children to discuss the policy document entitled *A Vision for Change*. There was particular focus on the intersection between Mental Health and the Criminal Justice process.

Reintegration of Prisoners was discussed in July. Agnieszka Martynowicz, spoke about the Irish Penal Reform Trust report, *"It's like stepping on a landmine..." - Reintegration of Prisoners in Ireland.*

# **UPDATE ON THE WHITE PAPER ON CRIME PROCESS**

The last decade has been marked by wideranging legislative and organisational changes in the Irish criminal justice system, accompanied by unprecedented resource allocation in measures to combat and prevent crime. Huge progress has been made across the board and the depth of the response to this complex issue has grown significantly. Many individual issues in the field have also been the subject of detailed study during this time and this work will inform the development of the White Paper.

Notwithstanding the progress made, crime remains a real and persistent problem and a subject of legitimate concern to many individuals and communities.

Against this background and in the context of ongoing social and cultural change in Irish society, it is timely and necessary to assess the systems and measures in place to prevent and combat crime and to plan for future policy development.

Members of the public, together with the relevant public agencies and other interested bodies are being given a full opportunity to contribute to the policy's formulation through the consultation process.

The first discussion document focused on Crime Prevention & Community Safety, the second on Criminal Sanctions and submissions are currently being accepted in relation to the third discussion document, Organised and White Collar Crime.

# WOMEN IN THE CRIMINAL JUSTICE SYSTEM

Our 13<sup>th</sup> Annual Conference was held on 15th October 2010 at the Camden Court Hotel, Dublin 2.

The event was a great success and was well attended by delegates from across the sector including government agencies, professionals, practitioners, academics and community workers providing the opportunity for an interesting and informative exchange of views from the multi-disciplinary participants.

The Hon. Mrs. Justice Catherine McGuinness, President of the Law Reform Commission, launched the conference and this was followed by the morning plenary sessions where Chief Inspector Kathleen O'Toole of the Garda Síochána Inspectorate gave an interesting and inspiring presentation on "Leadership in Criminal Justice, a Practitioners' Perspective" and Prof. Loraine Gelsthorpe from the Institute of Criminology, University of Cambridge brought attendees up to date with recent developments in England & Wales in relation to "Women Offenders and Community Penalties".

Delegates then attended their choice of 4 workshops which were expertly led by the various presenters and covered the topics of Media Profiling in the Criminal Justice System, North & South; Prostitution in Ireland Today – A Changed Reality; Gender & Policing; Community Based Interventions for Women Offenders in Northern Ireland.

During the afternoon session, Eimear Fisher, executive director of Cosc presented an insightful whirlwind review of the National Strategy on Domestic Sexual & Gender Based Violence and Dr. Azrini Wahidin concluded the plenary sessions with an informative outline of the issues and challenges facing older women in prison.

The workshops once again had the benefit of expert facilitators and focused on Women as Victims of Intimate Partner Homicide– Links with Domestic Violence; Mental Health Issues for Women in the CJS - Legal & Welfare Perspectives; Education for Young Women in Detention; Experience of Prison for Women and Homelessness.
